Submission of tender :

1) Completed sealed tender documents (part I & II) should be submitted at the same time. Part-I shall consist of any deviation from terms and conditions of the tender and additional terms and conditions if asked for, technical bid and credentials. Part-II shall consist of tender documents as sold to the tenderers duly filling in rates, amounts etc. i.e. price bid. The Earnest money deposit is to be submitted in a separate Envelope altogether superscribing "Earnest Money Deposit", and not inside the envelope containing Part-I or Part-II of the Bid. The Part-I & Part-II should also be put into separate sealed envelopes superscribed as such. Thereafter all the three envelopes should be submitted in a sealed envelope with appropriate superscription.

2) The tender will be received on 20/09/10 upto 11.00 A.M. at Dy GM(C), EWZ Sudamdih and will be opened at 11.30 A.M. on the same day in presence of the intending tenderer or their authorized representative in the Office of Dy GM(C), EWZ Sudamdih Only part-I will be opened on 20/09/10 at 11.30AM. The part-II will be opened only after the department is satisfied that the criteria fixed are fulfilled and also the earnest money is deposited i.e. on acceptance of part-I.

Eligibility criteria :

- Terms & Condition: The tender has to fulfill the following eligibility criteria (Documentary evidence to be submitted).

A Average annual financial turn over of Civil Works during the last 3 (three) years ending 31 st March of the previous financial year, should be at least 30% of the estimated cost.

B The intending tenderer must have in its name as a prime contractors experienced of having successfully completed similar works during last 7 (seven) years ending last day of Month previous to the one in which bid applications are invited (i.e. eligibility period) should be either of the following:

Three Similar completed work each costing not less than the amount equal to 40% of the estimated cost.

OR

Two Similar completed work each costing not less than amount equal to 50% of the estimated cost.

OR

One similar completed work costing not less than amount equal to 80% of the estimated Cost .
- The tender has to fulfill the following eligibility criteria (Documentary evidence to be submitted in support of 1A & B above in the form of certified copy of Work – Order, Completion Certificate , Payment Certificate/ Vouchers etc indicating the period of work for which the payment has been made , duly signed by Competent authority.

(ii) As per eligibility Criteria specified under Sl No. 3(a) Pre Qualification shall be done on experience of successfully completed works and not on Experience of works in progress
- The tender documents can be had from the Office of the Dy GM(EWZ)during the period mentioned above .
- Earnest Money is to be deposited with the Associates Finance in shape of Bank Draft drawn on any Nationalize Bank in favor of Bharat Coking Coal Limited Payable at Dhanbad . EMD can also be deposited in cash in the office of Cashier EWZ area office or concern washery office if possible. Complete sealed tender documents should be submitted in one envelope and E/M in separate envelope mentioning the same on envelope.. The tenderers must submit E.M as per NIT , sales Tax clearance certificate, PAN No.of Income Tax , TIN No. and documents of work done.

07. Conditional Tenders will not be accepted.
- 08 Issuance of tender documents does not mean that the parties are considered qualified.
- 09 Issue & submission of the tender paper: Tender paper can be obtained on any working day between 10AM to 3.00PM . The request letter to be submitted during office hours in the office of the undersigned during issue of tender period for obtaining a set of tender documents . Tender documents shall be issued to the tenderer or representative duly authorized to receive the tender documents in the person. Completed tender paper duly filled in to be submitted in the tender box in the office of the undersigned .
- Similar Work Means : Roof tar felting works for Job: Only manufacturer of Roof tar felting having license and their authorized agent are eligible . They are required to submit their ISI license in the technical Bid .
- 10 Validity : The validity of Tender will be 120 days from the date of opening of Price Bid or revised Price Bid, if any.
- 11 Performance security : 5% of the contract value shall have to be deposited including I EMD after acceptance of offer before work order and delay shall be to tenderer A/C only.
- 12 Credential & Certificate : All the credential & Certificate is to be submitted in the name & Style of the tenderer firm to whom tender paper was issued. Any other form shall not be accepted.
- 13 The Management of B.C.C.L. reserves right to reject any or all the tenders without assigning any reason what-so-ever and to split up and distribute the work & amount among the tenderes
- 14 The tenderer should submit the Affidavit in prescribed performa in the Non Judicial Stamp paper of Rs 20/- only.
- 15 For tar felting job the Guarantee period will be 5 years.
