ELIGIBILITY CRITERIA FOR ISSUANCE OF TENDER PAPER							

1. The intending tenderers must have in its name, experience of having successfully completed similar works during last 7 yrs. ending last day of month previous to the one in which bid applications are invited (i.e. eligibility period) and the same should be either of the following:

i) Three similar works completed successfully each costing not less than the amount equal to 40% of the estimated cost.
