**ELIGIBILITY CRITERIA FOR ISSUANCE OF TENDER PAPER**

---

1. The intending tenderers must have in its name, experience of having successfully completed similar works during last 7 years ending last day of month previous to the one in which bid applications are invited (i.e. eligibility period) and the same should be either of the following:
  - I. Three similar works completed successfully each costing not less than the amount equal to 40% of the estimated cost.

Or

Two similar works completed successfully each costing not less than the amount equal to 50% of the estimated cost.

Or

One similar works completed successfully costing not less than the amount equal to 80% of the estimated cost.
2. Average annual financial turn over during the last 3 years ending 31<sup>st</sup> March of the previous financial year should be at least 30% of the estimated cost.
3. Similar work means the tenderer should have experience of general civil work.

Note :- Provision under eligibility criteria No. 1 (i) shall also include those similar Work which have been started earlier than eligibility period of tender but completed during the eligibility period as per NIT

As per eligibility criteria specified under No. 1 (i) prequalification shall be done based on experience of successfully completed works and not on experience of successfully completed works and not on experience of work in progress.

**TERMS & CONDITIONS:-**

1. The tenders are to be submitted separately in two sealed covers containing (i) Technical bid & (ii) Commercial bid.
  - (i) The first sealed cover marked Part-I i.e. Technical bid should contain terms & conditions, details of previous experience, Earnest Money deposit receipt and other credentials.
  - (ii) The sealed cover marked Part-II i.e. Commercial bid should contain offer of the tender i.e. tender documents of company. The percentage should be mentioned both in figures and in words.
  - (iii) The sealed cover marked Part-I will be opened and scrutinised first and if the terms & conditions are fulfilled then part-II will be opened and intimated at a later date.

2. The estimate plan & specification of work can be seen in the office of the undersigned during working hours. Any other info can also be obtained from the undersigned.
3. The tenderer has to deposit E.M. as stated above with A.F.M. EJ Area in cash and the money receipt should be attached with the tender. The tender E.M. will be out rightly rejected.
4. The tenderer documents can be obtained from the office of the undersigned from 09/10/10 to 11/10/2010 during working hours on deposit of cost of tender paper.

6. The tender documents downloaded from the website cost of tender documents (application fee) should be submitted in a separate envelop marked Part-III along with an undertaking that the tender documents as available on the website is accepted.
7. The contractors have to submit permanent Account Number (PAN) of income tax and TIN.
8. The rate should be quoted inclusive all taxes and royalty. The validity period of the tender will be 120 days.
9. Materials required for the work are to be arranged /procured by the contractor.
10. The authority reserves the right to reject any or all the tenders received or split up and distribute the work between more than one contractor and no reason for the rejection of all or any of the tender will be given.
11. In case rates are not acceptable to the Management the offer may be rejected.
12. The experience in the eligibility criteria should be in the name & style in which the tender is filled. The experience of the partner or some other name & firm /company, will not be counted for this purpose.
13. The successful tenderer will have to deposit performance security money as per norms before issue of work order.
14. The tenderer must submit an affidavit with their offer as per civil engg. Manual & declaration that they have not been banned or delisted by any Govt. or quasi Govt. Agencies or PSUs.
15. Any Bank Draft Prepared after the scheduled closure of Sale or tender documents may be liable for rejection. Tender not accompanied with cost of tender documents may be liable for rejection.
