Both part-I & II envelopes are to be enclosed on one envelope with Tender Notice No., Due date etc. superscribed on the envelopes. The Ist. bid i.e. Technical bid should be enclosed with the earnest money and the other required documents. The Technical bid will be opened at 3.30 P.M. on the same date. Price bid will be opened only after the acceptance of the Technical bid.
