TERMS AND CONDITIONS:

GENERAL:

1. Quotation should be firm, F.O.R-Destination including risk in transits upto Sinidih Regional Stores.
2. Price quoted should be valid for minimum period of 120 days from the date of opening of quotation
3. Quotations should be free from corrections and erasures. Only type written offer is acceptable
4. Sealed quotation must be submitted in the Tender Box of Purchase Deptt. Govindpur Area – III. BCCL
5. Techno-Commercial Bid will be opened on due date and time as mentioned above. Price Bid of only those tenderers whose Techno-Commercial bid is found to be acceptable will be opened later on.
6. Cost of Tender Document Rs.1000/- in the form of Bank draft in favour of “BHARAT COKING COAL LIMITED. payable at Dhanbad, Must accompany Techno-Commercial bid if downloaded from website. Tender document can be purchased by intending tenderers by depositing cash Rs,1000/- in Area cash section and submission of original money receipt in Area Purchase Section, Govindpur Area-III.
7. Earnest Money: An Earnest Money of Rs,4200/- (Rs, Four Thousand Two Hundred Only) in the form of “Bank Draft” only of any schedule Bank drawn in favour “BHARAT COKING COAL LIMITED.” payable at Dhanbad, must accompany Techno-Commercial bid, otherwise

- offer will not be considered for further evaluation. For Un-successful tenderers Earnest money shall be refunded immediately after finalization of the tender.
8. Security Money: Successful Tenderers are required to deposit Security money in the form of "Bank Draft" only of any scheduled Bank drawn in favour "BHARAT COKING COAL LIMITED, payable at Dhanbad of 10% of value of order (Value means F.O.R destination Price) within 15 days of receipt of order, for unsatisfactory performance of contractual failure, the security money shall be forfeited. Security Money will be refunded after successful completion of supply in full after 12 month from the date of supply.
 9. Earnest Money of successful tenderers will be adjusted towards security money.
 10. State/Central Govt. Organization/Public Sector Undertaking/Valid DGS&D/NSIC registered firms (For tendered item) shall be considered for exemption for submission of Earnest Money & Security Money, If they submit documentary evidence in Techno-Commercial Bid.
 11. Payment Terms: 100% after receipt, inspection and acceptance of material at Govindpur Area-III Regional Store and submission of final bill (whichever is latter) within 30 days.
 12. Delivery: To be completed in one lot within 45 days from the date of formal order. Part supply will not be acceptable.
 13. Tenderers must mention CST No & State Sale Tax Registration No/VAT No/TIN No, in Techno-Commercial Bid.
 14. Price fall clause and L.D Clause acceptance must be given in the offer.
 15. Guarantee/Warranty: 5(Five) years from the date of use. In case of manufacturing defect found in guarantee/warranty period, supplier will have to replace the same on free of cost basis.
 16. C.M.R.I. tested certificate should be attached along with the delivery challan.
