2. ELIGIBILITY/ QUALIFICATION OF TENDERER:

- i). Only approved explosive van permitted (Registered in 2002 or there-after) i.e. not more than 10 years old.) To be deployed on hire as per Motor Vehicle Act and Explosive Act 1984 & Explosive 1983 be offered for this purpose i.e. the vehicle which are registered for commercial use for above purpose.
- ii) Vehicle is required to be roadworthy and in good running condition, with driver. In case of break down, substitute vehicles is to be arranged by the contractor. In case of failure penalty may be imposed at double the rate of hiring charge.
- iii) Vehicle is required to be covered under appropriate Insurance as per MV Act and should have been paid up to date Road Tax/Permit/fitness/pollution fee etc. as per MV Act along with valid Registration.
- iv) The liability of BCCL is restricted to payment of hiring charges as well as Running charges only, not for any other items whatsoever arising in connection with the use/nonuse of the said vehicle.
- v) The intending tenderer must have in its name as a prime contractor experience of having successfully completed similar works during last 7 (seven) years should be either of the following.
 - a) Three similar completed works each costing not less than amount equal to 40 % of the estimated cost.
 - Or
 - b) Two similar completed works each costing not less than the amount equal to 50 % of the estimated cost.
 - Or
 - b) One similar completed works each costing not less than the amount equal to 80 % of the estimated cost.

The Tender will be received on **15.11.10 upto 3.00 PM** only. Part-I will be opened on **15.11.10 at 04.00PM** on the same day. The Part-II will be opened only after department is satisfied that the criteria fixed are fulfilled i.e. on acceptance of Part-I.
5. The validity of the tender will be 120 days from the date of opening Price bid or revised price bid, if any.

The Earnest Money/Bid security of Rs. 5500/- for the van is to be deposited in form of demand draft drawn in favor of BHARAT COKING COAL LIMITED payable at Dhanbad on any schedule bank at its branch at dhanbad, with validity of 28 days beyond the validity of the bid documents.
