## **ELIGIBILITY CRITERIA:-**

- i) The intending tenderers must have, in the name experience and having successfully completed similar works during last (Seven) years
- ii) The intending tenderers must have, in the name experience of having successfully completed some similar works during last 7 years ending last day of month previous to the one in which applications are invited should be either of the followings:
  - a) Three similar completed works costing not less than the amount equal to 40% of the estimated cost.

Or

b) Two similar completed works each costing not less than the amount equal to 50% of the estimated value.

Or

- c) One similar completed work costing not less than an amount equal to 80% of the estimated cost.
- N.B."Similar work means the nature of work as described, in the name of the work should match with the work successfully completed in mines
- 1) The tenderers must have average annual financial turn over during last three years ending 31<sup>st</sup> March of previous financial year i.e. in 2007-08, 2008-09 & 2009-10 should be at least 30% of the estimated value.(to be submitted TDS Form -16).

- 2) Rate to be quoted in % above/below of the estimated cost both in figure and words in BCCL prescribed forms.
