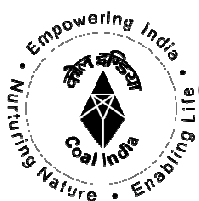

**ELIGIBILITY:**

1. The indenting tenderer must have in its name experience of having successfully completed similar works during last seven (07) years, ending last day of month previous to the one in which, bid application are invited, i.e. eligibility period) should be either of the following: -
  - a) Three similar completed works each costing not less than the amount equal to 40% of the estimated cost.
  - OR
  - b) Two similar works completed each costing not less than the amount equal to 50% of the estimated cost.
  - OR
  - c) One similar completed works each costing not less than the amount to 80% of the estimated cost.
2.
  - a) Average annual financial turnover of work during last three years ending 31<sup>st</sup> March of the previous financial year should be at least 30% of the estimated cost.
  - b) The intending tenderers should submit Sales-Tax Registration No. i.e. Tin Number/Pan No. & appropriate documents along with experience certificate in Technical Bid i.e. Part-I of Tender.

3. The tender documents can be had from the office of the Dy.General Manager (CP)/Project Officer (W), Madhuban Coal Washery, Block-II Area from 22.11.2010 to 23.11.2010 on deposition of requisite cost of tender paper in form of cash or Bank Draft of Nationalized Bank in favour of Bharat Coking Coal Limited, payable at Dhanbad.
4. Completed sealed tender documents Part-I & Part-II i.e.; Technical/commercial bid (Part-I) and Price Bid (Part-II) should be submitted at the same time.
5. Tender will be received on 25.11.2010 up to 3.00 p.m in the Office of the Dy.General Manager(CP)/P.O.(W) Madhuban Coal Washery, Block-II Area and same will be opened at 3.30 p.m on the same day in presence of the indenting tenderer or their authorized representative. Only Part-I will be opened on 25.11.2010 Part-II will be opened after scrutinizing the credentials for the criteria fixed for eligibility. The Management of BCCL reserves the right to reject any or all the tenderers without assigning any reasons whatsoever, or, to split up and distribute the work amongst the tenderers.
6. Copy of PAN Sale Tax clearance certificate copy attested by Gezatted Officer of the Govt. & team No. is to be furnished.
7. Status of Firm: Firm Registration/or partnership deed & power of attorney/Affidavit regarding proprietorship /articles of association etc.
8. Declaration that they have not been banned or de-listed by the any Govt. or Quasi Govt. or PSU.
9. Conditional /incomplete tenders will not be accepted and shall be outright rejected.
10. No tender will be issued or submitted by postal means.
11. The earnest money should be deposited in form of cash or draft from Nationalized Bank in favour of Bharat Coking Coal Limited, payable at Dhanbad. The earnest money is to be deposited as per details given in the tender documents.
12. Conditional tenders will not be accepted.
13. The experience as given in the eligibility criteria should be in the name and style in which tender is filled.
14. The validity of the tender will be 120 days from the date of opening of the bid or revised price bid, if any.
