General Instruction for submission of discount bids:

1)The contractor is required to submit his/her discount offer in sealed cover giving reference to this notice number and date as well clearly superscribing the cover co with the name of the work.Separate cover is to be used for each work.

2)The Bidders is encouraged to visit and examine the site of works and its surroundings and obtain all information that may be necessary for submitting the bid.

9)The tendered sum so corrected and altered shall be substituted for the sum

12)Penal action in case of failure on the part of the bidder.
