1.(A)The intending tenderer must have in its name & style as a prime contractor experience of having successfully completed similar works during 7 years ending last day of the month previous to the one in which bid applications are invited (i.e. eligibility criteria) should be eligible of the following. Three similar completed work each costing not less than the amount equal to 40% of the estimated cost. OR

Two similar completed work each costing not less than the amount equal to 50% of the estimated cost.

#### OR

One similar completed work costing not less than the amount equal to 80% of the estd. cost.

Similar Work means: For Job No.1,2 & 3 - :Civil Building Repair works.

(B)Av.annual financial turn over of similar work during the last 3 years ending  $31^{st}$  March of the previous financial year should be atleast 30% of estimated cost.

The intending tenderer must submit documentary evidence in support of (1) (a) & (b) above in the form of certified copy of work order, completion certificate, payment certificates/ vouchers, indicating the period of work for which the payment has been made, Duly signed by him/them.
