 - TECHNICAL/COMMERCIAL BID/PART-I:** - The Tenderers are required to furnish the details in respect of their work facilities & copy of last work order for similar type of job executed, besides all commercial terms such as Delivery, Guarantee, Transportation, Payment etc. as per NIT & details indicated in the Tender Paper.
 - PRICE BID/PART-II:** - Landed cost for execution of the aforesaid job in detail to be indicated.
- OTHER TERMS & CONDITIONS: -**

The Price Bid (**Part-II**) of only those Tenderers will be opened later on for whose **PART-I** offer/tender will be found to be Techno-commercially acceptable to Western Jharia Area, BCCL. The opening date & time of Price Bid (Part-II) will be intimated through a letter to only such bidders/Tenderers whose Part-I offer has been found acceptable.

- (iii) **EARNEST MONEY** : The earnest money for Rs. 6,478/- (Rupees Six thousand, four hundred, seventy-eight) only should be deposited along with the Tender Paper & offer in the form of Demand Draft drawn on any nationalized Bank at Dhanbad in favor of Bharat Coking Coal Ltd. and payable at Dhanbad.
