- 1. The tender documents can be had from the office of Sr. Manager (P) Admn, Koyla Bhawan, Dhanbad from 22.03.2011 to 28.03.2011 on production of credential in support of eligibility criteria, relevant terms of NIT and thereafter requisite cost of tender documents in the form of cash or bank draft of Nationalised bank in favour of Bharat Coking Coal Ltd., payable at Dhanbad.
