### Eligibility Criteria: -

- I. The intending tenderer must have in its name as a prime contractor having experience of successfully completed similar works during last 7(seven) years ending last day of the month previous to the one in which application is invited should be either of the followings:-

Three similar completed works each costing not less than the amount equal to 40% of the estimated cost.

Or

Two similar completed works each costing not less than the amount equal to 50% of the estimated cost.

Or

One similar completed work costing not less than the amount equal to 80% of the estimated cost.

- II. Average annual financial turnover of these supply works during the last 3(three) years i.e. (2007-08, 2008-09 & 2009-10) should be at least 30% of the estimated cost.

- III. Similar nature of work means supply of furnitures etc.

1. The tender documents can be had from the office of Sr. Manager (P) Admn, Koyla Bhawan, Dhanbad from **15.03.2011** to **21.03.2011** on production of credential in support of eligibility criteria, relevant terms of NIT and thereafter requisite cost of tender documents in the form of cash or bank draft of Nationalised bank in favour of Bharat Coking Coal Ltd., payable at Dhanbad.

5. The experience as given in the eligibility criteria should be in the name and style in which tender is filled. The experience in the name of some other firm / company will not be considered for this purpose.
6. The tenderer has to submit permanent account no. of income tax (PAN) and particulars of registration number with Sales Tax Clearance Certificate.

8. The validity of the tender will be 120 days from the date of opening of Price Bid or revised price bid if any.
