B. The tenders received will be opened on **30.03.2011** at 4.00 P.M. in the office of General Manager(Mining), Lodna Area, Dhanbad.

(1) Eligibility criteria :

(a) The intending tenderer must have in the name as prime contractor experience of having successfully completed similar work during 7 (seven) years sending last day of the month previous to the one in which bid application are invited i.e. eligible period should be either of the following :

Three similar completed works is costing not less than the amount equal to 40% of the estimated cost (OR)
OR

Two similar completed works is costing not less than the amount equal to 50% of the estimated cost.(OR)
OR

One similar work is costing not less than the amount equal to 80% of the estimated cost.

Similar works means : **Pipe line work (Water supply).**

(b) Average annual financial turnover of civil works during the last 3 (Three) years ending 31st March of the previous financial year, should be at least 30% of the estimated cost.

The intending tenderer must submit documentary evidence in support of (1)(a) & (b) above in the form of certified copy of work order, completion certificate, payment certificates/vouchers etc. indicating the period of work which the payment has been made, duly signed by him/them.

NOTE (i) Provision under eligibility criteria 1(a) shall also including three similar work “while considering the value of complete works, the full value of completed works be considered whether or not the date of commencement is within the seven years period.”

(ii) As per eligible criteria specified under Sl.No.1(a) Pre-qualification shall be done based on experience on successfully completed works and not on experience of work in progress.

(2) The tender document can be had from the office of the General Manager, Lodna Area, Civil Engineering Department, Lodna Area, BCCL, P.O. Khas Jeenagora, Dhanbad during the period mentioned above on deposition of requisite cost of tender paper in form of cash or Bank Draft of Nationalized Bank/Schedule Commercial Bank approved by Reserve Bank of India in favour of Bharat Coking Coal Limited, payable at Dhanbad.

(3) Completed sealed tender document (Part 'I' & Part 'II') should be submitted at the same time.

Part 'I' shall consist the PAN, TIN No., Work experience, Affidavit etc. copy of credentials.

Part 'II' shall consist the tender documents as sold to the tendrer, duly filled in for rates, amounts etc. i.e. price bid.

The Earnest Money deposit is to be submitted in a separate envelope superscribing “Earnest Money Deposit” (Earnest Money to be submitted in form of cash or Bank Draft of Nationalized Bank/Schedule Commercial Bank approved by Reserve Bank of India in favour of Bharat Coking Coal Limited, payable at Dhanbad.

The bid shall be submitted in three separate envelopes.

Envelope-I should contain EMD and the cost of tender document if down loaded from the Website.

Envelope-II should contain Part-I of tender document.

Envelope-III should contain Part-II i.e. Price bid.

Thereafter, all the three envelopes should be submitted in one sealed envelope.

Part-I will be opened only after receipt of EMD and in case of downloaded tender, the cost of tender document too.

Part-II will be opened only after the document is satisfied the criteria fixed are fulfilled i.e. on acceptance of Part-I.

(4) The Earnest Money is to be deposited as per detail given in the tender documents.

(5) Sales Tax clearance certificate copy attested by Gazetted Officer of the Govt.(Central or State) & TIN No.

(6) The tenderer have to submit Permanent Account No.(PAN) of Income Tax & Bank Account No.

(7) Conditional tenders can not be accepted.

(8) Every tenderer is required to give an Affidavit in the tender in stamp paper..

(9) Issuance of tender documents does not means that the parties are considered qualified.

(10) The experience as given in the eligibility criteria should be in the name and style in which tender is filled. The Experience in the name of some other firm/company will not be considered for this purpose.

(11) The validity of the tender will be 120 days from the date of opening of Price bid.
