1. ELIGIBILITY CRITERIA

- a) The intending Tender must have in its name as a prime contractor experience of having successfully completed similar works during last 7(seven) Years ending last day of month previous to the one in which bida applications are invited should be either of the following:-
- (1) Three similar completed works each costing not less then 40% of the estimated cost Or Two similar completed works each costing not less then 50% of the estimated cost Or (3)One similar completed work costing not less then 80% of the estimated cost. Similar work means: Building works.

- (b) Average annual financial turnover of civil works during the last three years ending 31st March of the previous financial, should be at least 30% of the estimated cost.
- 2.) The Tender documents can be had from the office of the undersigned during the period mentioned above on deposition of requisite cost of Tender paper in form of cash Bank draft of any nationalized bank/scheduled commercial bank approved by Reserve bank of India in favor of “Bharat Coking Coal Limited” Payable at Dhanbad.

Part I shall consist of terms & conditions of the Tender, additional terms and conditions if any, Technical bid and credentials.
