(1) ELIFIBILITY CRITERIA

A) The intending Tender must have in its name as priming contractor experience of having successfully completed similar works during last seven years ending last day of month previous to the one in which bid invited should be either of the following:-

- 1) Three similar completed works each costing not less than 40% of the estimated cost.or
- 2) Two similar completed works each costing not less than 50% of the estimated cost.
- 3) One similar completed work costing not less than 80% of the estimated cost

Similar work means:- pipe line & pipe fitting work

b.) Average annual financial turnover of civil works during the last three years ending 31st march of the previous financial should be at least 30% of the estimated cost.
