#### 1. ELIGIBILITY CRITERIA;

(a)The intending tenderer must have in its name as a prime contractor experience of having successfully completed similar works during 7(seven)years ending last day of month previous to the one in which bid applications are invited(i.e. from 01.05.2004 to 30.04.2011) should be either of the following:

Three similar completed works each costing not less than the amount equal to 40% of the estimated cost.

OR

Two similar completed work each costing not less than amount equal to 50% of the estimated cost.

OR

One similar completed work costing not less than the amount equal to 80% of the estimated cost.

### N.B. Similar work means: Rep. & maint./Const. of build.work for sl.no.1,2 & 3,PCC & brick work for sl.no.4 and civil Misc. Work for sl.no.5.

(b) Average annual financial turn over of civil work during the last 3(three) YEARS ENDING 31<sup>ST</sup> March of the previous financial year(i.e.2008-2009,2009-20010 & 2010-11) should be least 30% of the estimated cost(To be submitted T.D.S. Form-16).
