Part-II tender will be opened after due fulfilment of the eligibility criteria.

The first part ie Technical/commercial bid should consist of;-

- I) Firm registration or Partnership deed and power of attorney / affidavit regarding proprietorship / article of association etc.
- II) PAN Card.
- III) Valid Sales Tax Registration Clearance.
- IV) Credentials on satisfactory performance of contracts completed.
- V) Banking details as per the Format for e-payment
- VI) Other Techno- Commercial Terms and condition mentioned as Annexure -1 is to be complied otherwise the tender will be disqualified.
- VII)G.M (Rescue) reserves the right not to make any procurement against this tender without assigning any reason.

Part-II i.e. price bid of the bill of the quantities duly filled in rates/ amount etc. Part-1 & II should be submitted in two separated sealed envelope superscribed as such:-

ELIGILIBILITY CRITERIA: -

- 1. Experience of having successfully completed similar work during the last seven years ending last day of month previous to the one in which applications are invited should be either of the following:
 - a. Three similar completed work costing not less than the amount equal to 40% of the estimated cost.

or

b. Two similar completed work costing not less than the amount equal to 50% of the estimated cost.

or

- c. One similar completed work costing not less than the amount equal to 80% of the estimated cost.
- 2. Average annual financial turn-over of the work during the last three year ending 31st March of the previous financial year should be at least 30% of the estimated cost.

Note: Similar work means working experience as Supplier of Medical Oxygen.

OTHER TERMS & CONDITIONS:-

- 1. The experience as given in the eligibility criteria should be in the name & style in which the tender submitted. The experience of the partner, if any, in the name of the other firm/ company will not be considered for this purpose.
- 2. In case where tender documents are requested for sending by post, this would be dispatched by Registered AD. The department is not responsible for any postal delay in such cases.
- 3. Conditional tenders will not be accepted.
- 4. Issuance of tender document does'nt mean that the parties are considered qualified.
- 5. The responsibility for arrangement of all input materials required for the work shall be with the contractor/supplier.
- 6. The Management of BCCL does not bind itself to accept the lowest tenderer and reserve the right to reject any or all the tender without assigning any reason whatsoever and to split-up the work and distribute between two or more tenderer or accept the tender in part and or in entirety.
- 7. The contractor/ supplier shall have to abide by all the rules and regulations as per contract labour (Regulation and Abolition Act-1970 & Central Rules-1971). The contractor/ supplier shall be exclusively responsible for payment to his workmen / labourer as per Minimum Wages Act enforce and no liability on this account shall be accepted by the BCCL Management.
- 8. The original bill document issued to the bidder duly signed by authorised signatory of the bidder on all pages as a proof of accepting the conditions of contract (excluding the price bid)

- 9. Other details may be obtained from the detailed tender notice/ tender document mentioned above.
- 10. The contents of the tender documents available for sale in our office shall be deemed as authenticated and the responsibility of errors and omission in the downloaded documents will be with the tenderers.
- 11. The validity of the tender will be 120 days from the date of opening price bid or revise price bid if any.
- 12. The bidder must give a declaration that they have not been banned or delisted by any Govt. Or any PSUs. This fact must be clearly stated and it may not necessarily be a cause for disqualifying them. If this declaration is not given the bid will be rejected as non-responsive.

Techno-commercial terms and condition:-

- 1. Empty mother cylinders shall be collected from Mines Rescue Station, Dhansar in a lot of 8 to 14 nos. within 8 hours of intimation that will be given over telephone by Rescue Station Incharge.
- 2. Suppliers shall arrange to supply refilled Oxygen Cylinder at Mines Rescue Station, Dhansar within 72 hours of collection of empty cylinder.
- 3. During Emergency party/ supplier may be asked for supply of refilled mother cylinders even at shorter notice.
- 4. Suppliers have to make their own arrangement for collection of empty / refilled mother cylinders (including loading and unloading of mother cylinders) from and to Mines Rescue Station, Dhansar.
- 5. Suppliers have to provide Oxygen purity test certificate to comply with the Schedule –VI, 3 of Mines Rescue Rule -1985 that medical oxygen supplied should not contain more than 1% impurities in each lot of supply.
- 6. Suppliers/ party must mention their rates on F.O.R destination (i.e. Mines Rescue Station Store, Dhansar). VAT rate or other taxes whichever is applicable is to be mentioned separately on the amount of rate on which the taxes is to be charged.
