- b). where there is a discrepancy between the unit rate and the line item total resulting from multiplying the unit rate by the quantity, the unit rate as quoted will govern.

- 8. The tendered sum so corrected and altered shall be substituted for the sum originally tendered and considered for acceptance instead of he original sum quoted by the bidder alongwith.
