The tenders are to be submitted in the tender box placed in office of the Area Manager, Govindpur Area E&M Department. The sale of tenders shall be stopped one day prior to the last day of submission of tender. TENDER DOCUMENT

1. **ELIGIBILITY:** The tenderer must have experience of **SIMILAR** work done during last seven years ending last day of month previous to the one in which applications are invited should be either of the following.

(a.) Three similar completed works each not less than the amount equal to 40 % of the estimated cost.

Or

(b) Two similar completed works each not less than the amount equal to 50 % of the estimated cost.

Or

(c) One similar completed works each not less than 80 % of the estimated value of tender.

NOTE:- Similar Work means Contractual jobs.

2. The average annual financial turn over during the last 3 financial years ending 31st March should be at least 30 % of the estimated value.

3. The tenderer must submit copy of S.S.I. registration No & copy of PAN of firm/proprietor .The tenderer shall be barred from taking part in future tender if any document/Information submitted by tenderer is found to be incorrect/false and a certificate in judicial stamp paper have to be submitted along with tender documents.

4. In case of any electrical Overhead work or house wiring, valid electrical license from the state authority has to be submitted and competence supervisory certificates from state govt. under which the work will be supervised have also to be submitted along with the offer.

5. **WARRANTY:** If any item repaired against the work order fails because of poor workmanship or quality, the same shall be repaired/replaced free of cost within 15days falling which the LD clause as Sl. No.10 will be applicable & the company shall have to power to recover repairing cost of the failed items from any of pending bills of the repairer. If any assembly is repaired departmentally during warranty period the total cost of repair including spares, manpower & other overhauled cost, will be recovered from the contactor.

6. **PAYMENT:** 90 % payment will be made within 30 days of submission of bill after successful completion and acceptance of job. The firm will be required to submit the bank details in the prescribed format along with tender document. The bank details may be submitted in the original copy or through a photocopy attested by bank.

7. **SECURITY DEPOSIT:** Balance 10 % payment shall be kept as security deposit & will be released after successful completion of warranty/guarantee period.

8. **EARNEST MONEY:** 1 % of tendered value is to be deposited along with the Techno commercial bid in the form of DD favoring **Bharat Coking Coal Limited** payable at **Dhanbad**. The same shall be returnable after the finalization of the tender for the

unsuccessful bidder & for the successful bidder the same shall be adjusted towards the security deposit.

9. **SAFETY:** Precaution should be taken by the tenderer in case of job undertaken at our site. Name of persons Engaged in work at site will be maintained in the register & signed by Engr I/C (**E&M**) of the project. In case of any Injury/accident it will be responsibility of the contractor to pay all legal dues to their workers.

10. **L.D. CLAUSE:** Liquidity damager will be charged @ ½ % per week or part of subject to maximum of 10 % of the total cost awarded value for delay in completion of work. The same L.D. clause will apply to the delay in repair/replacement incase of failure under warranty/guarantee.

11. **OFFER VALIDITY:** Minimum validity of 90 days from the date of opening of the techno-commercial bids of the tender.

12. Rate must be written in figures & words, if there is a variation, the rate written in words shall be considered only. Government taxes may be deducted at source as per rule/guideline.

13. All materials, equipment, tools & tackles along with manpower required for the works will be required to be arranged by the tenderer at his cost. The **BRAND/MAKE** of the electrodes used if any along with their **PRODUCT NAME & QUANTITY** will have to be mentioned in the techno-commercial bids. Only crane & electricity will be provided whenever needed for work at site, free of cost. The requirement must be for a specific period & in advance by one day in case of crane.

14. All the required documents are to be submitted along with techno-commercial bid. The price bid should contain the price only along with price breakup. The quoted offer should be exclusive of service tax. Service tax will be paid extra, as applicable. However, tenderer has to furnish a certificate at the time of claiming reimbursement stating the rate of service tax at which the service tax has been paid & confirming the reimbursement for this amount has not been claimed for any place, anywhere in India.

15. The tenderer must clearly indicate the nature & details of work in the tender submitted by them. All submitted documents must be signed by the tenderer. The tenderer are advised to do their page numbering & also enclosed a list of enclosure. All envelop must be super scribed with the tender Notice No, Name of work & type on bid and the bids should be sealed. The tenderer or their authorized representative may be present at the scheduled time of opening of tenders & their presence shall be noted.

16. Tenders may be rejected if the required documents are not enclosed. Right to accept or reject any or all the tenders is reserved without assigning any reason thereof.

17. The firm will be required to mentioned the name of their authorized persons with contact number to whom the contact can be made in case failure under warranty. The Information thus given shall be followed by information in writing. However, the time of failure shall start from the tine of Information is given over telephone.

18. Matter relating to any dispute or difference arising out of this tender and subsequent contract awarded based on the bid shall be subject to jurisdiction of Dhanbad Court only.

NOTE:

1. Service tax will be paid on labour charges only.
2. If service tax will be charged, a photocopy of the service tax registration certificate must be submitted with the tender.
