1. The estimate & specification of the work can be obtained from the office or can be downloaded from BCCL web site <http://bccl.gov.in> from 09.11.2011 to 12.11.2011. Any other information can also be obtained from the undersigned.
2. The quotationer have to submit Photo stat copy of PAN Card and latest sales tax clearance certificate
3. The tender has to deposit E.M. as stated above with A.F.M., EJ Area in cash . The Money receipt of EM should be attached with the tender. The tender without earnest money will be out rightly rejected.
5. The quotationer must submit an affidavit with their offer as per civil engg. Manual along with certification that they have not been banned or delisted by any Govt. Agencies or PAUs.
6. The contractors have to submit Permanent Account Number(PAN) income tax and TIN.
7. Authority reserves the rights to reject any or all the tenders received or split up and distribute the work between more than one contractor without assigning any reason what so ever
