a). The intending tender must have in its name as a prime contractor experience of having successfully completed similar works during last 7(seven) years ending last days of the month previous to the one which bid applications are invited should be either of the following:-(1). Three similar completed works each costing not less than 40% of the estimated cost. Or (2). Two similar completed works each costing not less than 50% of the estimated cost or (3). One similar completed works costing not less than 80% of the estimated cost. **Similar work means: Building works for sl.no. 1, Drilling of 8" dia. Borehole including installation of submersible pump for sl.no. 2 & 4 and building work with concertina wire fencing for sl.no. 3**

b). Average annual financial turnover of civil works during the last three years, ending years, ending 31st. March of the previous financial should be at least 30% of the estimated cost.
