In a tender floated vide NIT: BCCL/GM(Admn)/CTP/2019/491 dated:21/10/2019, you became L-1 and accordingly LOA vide: BCCL/HOD (Admn)/CTP/2020/1001 Dated:27/01/2020 was issued to you. As per the Terms and Conditions of NIT/TD/LOA, you have to deposit performance security deposit & additional performance security deposit within 28 days from the date of receipt of LOA along with the other terms to fulfill within the time frame. Since, you didn't submitted performance security deposit & additional performance security deposit within 28 days, on your request, another 15Days time was provided to you to deposit the same and fulfill the other terms of LOA in full. The another 15Days time provided to you was lapsed on 04/03/2020 but you failed to deposit performance security deposit & additional performance security deposit and you failed too to fulfill other terms & conditions of LOA in full.

3. To debar M/s Bajrangi Transport from participating in any future bids of BCCL for a period of 12 (Twelve) months.
