a) The intending tenderer must have in its name as a prime contractor experience of having successfully completed similar works during last 7 (seven) years ending last day of month previous to the one in which bid application are invited (i.e. eligibility period) should be either of the following :-

Three similar completed works each costing not less than the amount equal to 40% of the estimated cost. OR

Two similar completed works each costing not less than the amount equal to 50 % of the estimated cost. OR

One similar completed work costing not less than the amount equal to 80% of the estimated cost.

Similar Work Means:- Const. of building / Repairing maint. of building Works

b) Average annual financial turnover of civil works during the last 3(three) years, ending 31^{st} March of the previous financial year, should be at least 30% of the estimated cost.

Note :- (1) Provision under eligibility criteria 1.(a) shall also include those similar work "while considering the value of completed works , the full value of completed works be considered whether or not the date of commencement is within the said seven years period."

ii) As per eligibility criteria specified under Sl. No. 1 (a) Pre- qualification shall be done based on experience of successfully completed works and not on experience of the work in progress.
