- 3)The bidders shall offer for the whole works as described in bill of quantity submitted by the Bidder. However, the Employer reserves the right to allot part of the work at their discretion and not claims, whatsoever, shall be entertained in this regard.
- 4)The Bidder shall fill-in rates and prices for all items of the works describes in the Bill of Quantities. - 9)The tendered sum so corrected and altered shall be substituted for the sum
