MINUTES OF PREBID MEETING

Name of work - Preparation of stowing material from over burden of mines for stowing in mines of BCCL invited vide NIT NO – BCCL / CMC/ F- NIT / Stowing Material / 2011 / 324, Date 13.06.2011

As per terms of NIT a Pre Bid meeting in connection with subject tender was held on 20.07.2011 at 11:30 AM at Koyla Bhawan, BCCL. Representatives of the intending tenderers participated in the pre-bid meeting. Following quarries were raised by the intending tenderers which were clarified as follows:-.

SNo	Quarries raised by the intending tenderers	Clarification
1	The intending tenderers have stated that since the subject work is a new/recent technology and still not widely practiced for execution therefore to meet the eligibility criteria of experience of having successfully executed /executing of similar nature work valuing 65% of the annualised value of the work is tough as such some relaxation should be given in this clause. One of the tenderers have also submitted a written request letter which states Quote The experience clause may be considered for competitive bidding as the technology is new and in India only one plant is running for last few months. Unquote	The tenderers were informed that no change/deviation in NIT/Tender conditions is permitted at this stage.
2	One of the intending tenderers have stated that 4 hectares of land will be insufficient to set up plant for preparation of 49,38,000cum of stowing material in 6 yrs at an annual rate of 8,23,000 cum. He has also submitted a request letter which states Quote The land requirement should be enhanced from 4 hec to 6 hec (2 hec extra for tailing ponds) as the quantity / annum is around 9 lakhs cum when compared to SCCL 3 lakhs. Unquote	The tenderers were again informed that no change/deviation in NIT/Tender conditions is permitted at this stage.
3	The intending tenderers have enquired whether the performance security to be deposited before execution of agreement is 5% of award value.	It was clarified that the performance security deposit is to be deposited before issuance of work order is 5% of annualized award value.
4	The intending tenderers have asked for site & location plan.	Site & location plan have been provided to the intending tenderers. Any other intending tenderers may collect the plans from the office of the GM(CMC) BCCL, Koyla Bhawan if they feel so desired.
