**1. ELIGIBILITY CRITERIA**

- a) The intending Tender must have in its name as a prime contractor experience of having successfully completed similar works during last 7(seven ) Years ending last day of month previous to the one in which bida applications are invited should be either of the following:-
  - (1) Three similar completed works each costing not less then 40% of the estimated cost Or Two similar completed works each costing not less then 50% of the estimated cost Or (3)One similar completed work costing not less then 80% of the estimated cost. **Similar work means: Building works.**
  - (b) Average annual financial turnover of civil works during the last three years ending 31<sup>st</sup> March of the precious financial, should be at least 30% of the estimated cost.
- 2.)
