1. **Earnest Money / Bid Security:**

Rs.17622/- (Rupees Seveteen Thousand Six Hundered Twenty Two) only (1% of the estimated cost rounded to nearest hundred rupees subject to maximum of Rupees fifty lakhs) as Earnest Money/Bid Security is to be deposited in the form of irrevocable Bank Guarantee form any Scheduled Bank at its branch at Dhanbad / Kolkata with validity 28 (twenty-eight) days beyond the validity of the Bid in the format given in the Bid Document. Only Demand Drafts will also be acceptable as Earnest Money / Bid Security drawn in favour of Bharat Coking Coal Limited on any Scheduled Bank payable at its branch at Dhanbad.The Earnest Money/Bid Security of the unsuccessful Bidders shall be refundable as promptly as possible after opening of Price Bid and finalization of the tender and shall bear no interest.

2. Eligibility Qualification of Tenderer:

- i) The vehicle to be engaged should be road worthy in mines and in good running condition.
- ii) The tenderer will submit Xerox copies of all the statutory documents like license for road /explosive vans issued by the Competent Authority to carry explosive, vehicle ownership (registration certificate), road permit, road tax token, insurance certificate, fitness certificate as per M.V.Act at the time of submission of tender paper as well as before the expiry of the same in part-I (Technical Bid)
- i) The vehicle to be engaged for transportation for explosive and accessories exclusively from Magazine to different mines of Govindpur Area.
- ii) The owner of the vehicle will have to provide driver and khalasi in all the three shifts. The driver must have valid driving license issued by competent authority.
- iii) All expenses concerning vehicle, cost of POL, wages of driver and khalasi , repair and maintenance cost of the vehicle will have to be borne by the owner of the vehicle.
- iv) Kilometer run of the vehicle should be maintained regularly in the Log Book with signature of the person using the van and Xerox copy of work order and Log Book will be attached with the running bill.
- v) The contract shall be for a period of one year from the date of engagement of the vehicle.
- vi) The notice of termination will be three months from either side.
- vii) The vans must be available on all the days for 24 hours to cover all the 3 shifts.
- viii) Unauthorized person will not be allowed to travel in the explosive van during the journey.
- ix) Preference will be given to those who are having a fleet of vehicles of their own and have the experience of such type of job.
- x) The running charges will be based on H.S.D. price. There will be escalation / de-escalation in the price clause of H.S.D. in case of +/- 5% variation in diesel price.
- xi) Sales Tax, Service Tax & other Statutory Taxes will be applicable as per existing rules.
- xii) H.S.D., lubricants etc. will be provided by the owner of the vehicle.
- xiii) In case of off road / break down of explosive vans, owner of the vehicle will have to provide the replacement immediately under intimation to the management otherwise double of hiring charges for the said period of break down / non-deployment will be deducted from the running bill as a penalty for non plying of the vehicles.
- xiv) The explosive van's license must be issued from the office of the Jt.Chief Controller of Explosive, East Circle, Kolkata.

3. Price of tender Documents:

The application fee for Tender Documents shall be Rs.1000/- (as per Manual) (Non-refundable) payable either in cash or by Bank Draft drawn in favour of Bharat Coking Coal Limited, on any Scheduled Bank payable at its Branch at Dhanbad.
