1. ELIGIBILITY CRITERIA

a). The intending tenders must have in its name as a prime contractor experience of having successfully complete similar works during last 7 (seven) years ending last day of months previous to the one which bid applications are invited should be either of the following :- (1) three similar completed works each costing not less than 40 % of the estimated cost. Or (2) two similar completed work each costing not less than 50 % of the estimated cost or (3) one similar completed work costing not less than 80 % of the estimated cost. **Similar work means: covering /filling of illegal mining work .**

b.) Average annual financial turnover of civil works during the last three years, ending 31st. March of the previous financial, should be at least 30% of the estimated cost.
