Availability of Bid document: - Bid document comprising of this along with respective bill of quantities for the above may be collected from the office of the Dy Manager (Survey), C/ V Area, Barakar during the working hours of any working day free of cost within 09.10.2011.

Date of receipt of discount bids: - on 10.10.2011 up to 3.00 PM

Date of opening of discount bid : - The discount bids shall be opened at 4.00 PM on 10.10.2011 in the office of the GM (Mining), C/V Area.

Validity period of discount bid offers : - The rates offered shall remain valid for four calender months from the date of opening of discount bids.

General instructions for submission of discount bids : -

- 1) The contractor is required to submit their discount offer in sealed covergiving reference to this notice number and date as well clearly superscribning the cover with the name of the work separate cover is to be used for each cover.
- 2) The bidder is encouraged to visit and examine the place of works and its surroundings and obtain all information that may be necessary for submitting the bids. The cost of visiting the site shall be at the bidders own expense and it shall be demed that the bidder has visited the place/area.
- 3) The bidder shall offer for the work as described in the bill of quantity submitted by the bidder. However, the employer reserves the right to allot part of the work at the discretion and no claim, whatsoever, shall be entertained in this regard.
- 4) The bidder shall fill in rates and prices for all items of works described in the bill of quantities. Corrections if any shall be made by crossing out, initialling, dating and rewriting.
- 5) any bid received by employer after the deadline prescribed by the discount bid notice due to any reason whatsover will not be acceptable.
- 6) Information relating to the examination, clarification, evaluation and comparson of bids and recommendation for the award of a contract shall not be disclosed to the bidders or any other person not officially concerned with such process until the award to the successful bidder has been announced. Any effort by a bidder to influence the employers processing of bids or award decision may result in the rejection of their bids.

- 7) Bids determined to be substantially responsive will be checked by the employer for any arithmetical errors. Errors will be corrected by the employers as follows.
- a) where there is a discrepancy between the amounts in figures and in words, the amounts in words will govern; and
- b) Where there is discrepancy between the unit rate and the line item total resulting from multiplying the unit rate by the quantity. The unit rate as quoted will govern.
- c) Discrepancy in totalling or cary forward in the amount quoted by the contractor shall be corrected.
- 8) The tendered so corrected and altered shall be substituted for the sum originally tendered and considered for acceptance instead of the original sum quoted by the bidder alongwith. The amount stated in the bid will be adjusted by the employer in acordance with the above procedure for the correction of errors and shall be considered as binding upon the bidder
- 9) The bidder whose bid has been accepted, will be notified of the award by the employer conformed by registered letter. This letter (herein after and in the conditions of contract called the " Letter of Acceptance") will state the sum that the employer will pay the contractor in consideration of the execution and completion of the works by the contractor as prescribed by the contract (herein after and in the contract called "The Contract Price"). The notification of award will constitute the formation of contract subject only to the furnishing of a performance security / initial security deposit in accordance with the conditions of the SOR LCV 2010.
- 10) Matter relating to any dispute or difference arising out of this tender and subsequent contract awarded based on the bid shall be subject to the jurisdiction of Dhanbad Court only.
- 11) Penal action in case of failure on the part of the bidder, the registration of the SOR contractor shall stand cancelled and withdrawn in case the successful bidder fails within the specified time limit to furnish the required performance secutity/ initial security deposit, sign the aggreement and the bidder does not start the work within stipulated time. Once the SOR rigistered contractor is penalised on the count, he may as a special case appeal to the Director concerned, BCCL for re-registration for which the de-listed SOR contractor will have to deposit Rs. 1000/- towards re-registration fee (non-refundable) on receipt of demand from BCCL management to deposit the same. However, re-registration of a delisted SOR contractor will be on the sole discretion of BCCL management.
- 12) The bidder has to submit the copy of registration, Pan card, Insurance, road tax, pollution certificate and fitness.

The company is not under any oblligation to accept the lowest bid and reserves the right to reject any or all discount bids without assigning any reason whatsoever and also to distribute the work and allot the work/works to more than one bidder at its sole discretion.
