- a) Three similar completed works each costing not less than the amount equal to 40% of the estimated cost. OR
- **b)** Two similar works completed each costing not less than the amount equal to 50% of the estimated cost. OR
- c) One similar completed works each costing not less than the amount to 80% of the estimated cost.
  a) Average annual financial turnover of work during last three years ending 31<sup>st</sup> March of the previous financial year should be at least 30% of the estimated cost.

b) The intending tenderers should submit Sales-Tax Registration No. i.e. Tin Number/Pan No. & appropriate documents along with experience certificate in Technical Bid i.e. Part-I of Tender.

- 2. - 7. Declaration that they have not been banned or de-listed by the any Govt. or Quasi Govt. or PSU.
