- 2. TYPE OF TENDER: Sealed & typed tenders are to be submitted in two parts separately sealed and super scribed on the top of the Part-I (Technical/Commercial Bid) & Part-II (Price Bid) respectively.

The Price Bid (Part-II) of only those Tenderers will be opened later on for whose PART-I offer/tender will be found to be Techno-commercially acceptable to Western Jharia Area, BCCL. - (iii) **EARNEST MONEY**: The earnest money for Rs. 1,270/- (Rupees One thousand, two hundred-seventy) only should be deposited along with the Tender Paper & offer in the form of Demand Draft drawn on any nationalized Bank at Dhanbad in favor of Bharat Coking Coal Ltd. and payable at Dhanbad.
