**EARNEST MONEY** : The earnest money for Rs. 7,981/- (Rupees Seven thousand, nine hundred, eighty-one) only should be deposited along with the Tender Paper in the Part-I offer in the form of Demand Draft drawn on any nationalized Bank at Dhanbad in favour of Bharat Coking Coal Ltd. and payable at Dhanbad. This should be enclosed along with Techno-commercial Bid (Part-I). The offer, if found without earnest money, same will be rejected/cancelled.
