**3. OTHER TERMS & CONDITIONS: -**

The Price Bid (**Part-II**) of only those Tenderers will be opened later on for whose **PART-I** offer/tender will be found to be Techno-commercially acceptable to Western Jharia Area, BCCL. The opening date & time of Price Bid (Part-II) will be intimated through a letter to only such bidders/Tenderers whose Part-I offer has been found acceptable.

(a) Three similar completed work each consisting not less than amount equal to 40% of the estimated cost. **OR** (b) Two similar completed work each consisting not less than amount equal to 50% of the estimated cost. **OR** (c) One similar completed work each consisting not less than amount equal to 80% of the estimated cost.

(vi) **PROPRIETORSHIP CERTIFICATE:-** An Affidavit for Proprietorship/Partnership Deed to proof the firm/Company etc. must be submitted along with offer i.e. with the PART-I Bid.
