3. Technical Parameters:- The intending bidders must have in their name having successfully completed the similar nature of work in Government/Public sector undertaking in last 7 years ending with the last day of the month previous to the one in which bid application are invited, should be as following:-

- (i) Three similar completed works each costing not less than the amount equal to 40% of the estimated cost Or
- (ii) Two similar completed works each costing not less than the amount equal to 50% of the estimated cost. Or
- (iii) One similar completed works each costing not less than the amount equal to 80% of the estimated cost.

Similar Nature of work Means:- Commissioning /Installation of 1.1 KV grade Overhead Line works.

- 4. 10% security money including the Earnest Money will be withheld for a defect liability/guarantee period of six months from the date of handing over.
