GENERAL INSTRUCTION FOR SUBMISSION OF DISCOUNT BIDS:-

- 1. The contractor is required to submit their discount bid offer in sealed cover giving reference to this notice No. and date as well as clearly subscribing the cover with name of the work.
- 2. The bidders are encouraged to visit and examine the rout in which Bus is to ply and obtained all information that may be necessary for submitting the bid. The cost of visit in the site shall be at the bidder's own expense and it shall be deemed that the bidder has visited the site/area.
- 3. The bidder shall offer for the whole work as described in bill of quantity submitted by the bidder. However, the employer reserves the right to allot part of the work at their discretion and no claims, whatsoever, shall be entertained in this regard.

- 4. The bidder shall fill in rates and price of all items of the works described in the bill of quantities. Correction, if any, shall be made by crossing out, initiating, dating and rewriting.
