Eligibility Criteria:-

1) The intending tenderer must have its name as a prime contractor experience of having successfully completed similar nature of job during last 7(Seven) years ending last day or month previous to the one in which bid applications are invited (i.e. from 01.07.2006 to 31.06.2013.) should be either of the following:-

i) Three similar completed works each costing not less than the amount equal to 40% of the estimated cost.

OR

ii) Two similar completed works each costing not less than the amount equal to 50% of the estimated cost.

OR

iii) One similar completed works each costing not less than the amount equal to 80% of the estimated cost.

iv) Similar works Means: Construction/Repairing of building.

2) Average annual financial turnover of civil works during last three years ending 31st March of the previous financial year (i.e for, 2010-11, 2011-12 & 2012-13) should be at least 30% of the estimated cost.
