 - 2)The Bidders is encouraged to visit and examine the site of works and its surroundings and obtain all information that may be necessary for submitting the bid. The costs of visiting the site shall be at the Bidders own expense and it shall be deemed that the bidder has visited the site/area.

 - 9) The tendered sum so corrected and altered shall be substituted for the sum
 Originally tender and considered for acceptance instead of the original sum quoted by
 the bidder alongwith. The amount stated in the Bid will be adjusted by the Employer in
 accordance with the above procedure for the correction of errors and, shall be considered as
 binding upon the Bidder.
