The tender should be submitted in two parts i.e. Part-I & Part-II, Part-I i.e.

Technical/Commercial bid should consist of:-

- 1) Earnest money deposit particulars (E.M. is to be deposited with Area Finance Manager, Kusunda Area or in the form of Bankers cheque/Demand Draft of any Nationalized Bank drawn in favour of BCCL).
- 2) Firm registration or partnership deed and power of attorney/affidavit regarding Proprietorship/Article of Association & other declarations etc. in the prescribed format.

- 5) Credentials on satisfactory performance of contracts completed

6) Penalty :-Penalty for late completion of job will be charged @1%per week to a maximum of 10%. of the awarded value.

Part-II i.e. price bid shall consist of the bill of quantities duly filled in with rates/amount etc.

Part-I & Part-II should be submitted in two separate sealed envelopes super scribed indicating technical bid & price bid.

ELIGIBILITY CRITERIA:-

- 1) Experience of having successfully completed similar work during the last 7 (seven) Year ending last day of month previous to the one in which applications are Invited should be either of the following:-
 - a) Three similar completed work each costing not less than the amount equal to 40% of the estimated cost.

OR

- b) Two similar completed work costing not less than the amount equal to 50% of the estimated cost.

OR

- c) One similar completed work costing not less than the amount equal to 80% of the estimated cost.

NOTE: - Similar work means: - 1) Structural including dismantling and fabrication of M.S. members, 2) Installation of mechanical components.

- 2) Average annual financial turn over during the last 3 (three) years ending 31st March of the previous financial year should be at least 30% of the estimated cost.
- 3) The experience as given in the eligibility criteria should be in the name & style in which the tender submitted. The experience of the partner, if any, in the name of the other firm/company will not be considered for this purpose.
- 4) In case where tender documents are requested for transmission by post, these would be dispatched by Registered A.D. The department is not responsible for any postal delay in such cases.
- 5) Tender without earnest money shall out rightly is rejected.
- 6) Conditional tenders will not be accepted.
