1. (a) Part –I i.e. Technical/Commercial Bid should contain the proof of credentials, earnest money deposit, sale Tax Clearance/VAT & PAN. The Part –I will be opened on 14.11.2011 at 3.30 P.M. in the office of the Addl.General Manager, Sijua Area in presence of the tenderers or their authorized representatives.

(b)Part- II i.e. price bid, containing the Tender Documents issued to the tenderers, rate will be furnished in figures and words and will be opened by the tender committee only on acceptance of the Part –I Bid.

2. The Tender paper can be had from the office of the undersigned on written request on all working day during working hours from 07.11.2011 to 09.11.2011 on payment of requisite cost as indicated above to be deposited in cash with associate finance at Sijua Area.

ELIGIBILITY CRITERIA :-

The intending tenderers must have, in the name as a prime contractor of experience having successfully completed similar works during last 7 (seven) years ending last day of month previous to the one in which applications are invited should be either of the following :-

a) Three similar completed works each costing not less than the amount equal to 40% of the estimated cost.

Or

b) Two similar completed works each costing not less than the amount equal to 50% of the estimated value.

Or

c) One similar completed work costing not less than an amount equal to 80% of the estimated cost.

N.B.”Similar completed works means, civil construction works successfully completed in underground mine.”

3 The tenderers must have average annual financial turn over during last three years ending 31st March of previous financial year i.e. in 2008-09, 2009-10 & 2010-11 should be at least 30% of the estimated cost.

4. Rate to be quoted in % above/below of the estimated cost both in figure and words in prescribed form, issued to tenderers.
5. The contractor have to acquainted with the site condition.
6. All Taxes as applicable will be born by the Contractor.
7. The tenderers have to submit their name of Bank, name of branch & bank a/c number.
8. The Earnest money to be deposited in cash with associated finance at Sijua Area or in form of Demand Draft in favour of Bharat Coking Coal Ltd., Dhanbad. Earnest money bears no interest and may be refunded only to the unsuccessful tenderers in due course on completion of formalities.
9. Tenderers have to be fully acquainted and satisfy themselves with the NIT & site condition, drawings, estimates etc. before submitting their tenders.
10. All other terms and conditions of General NIT Rules of BCCL and/or other authorities/statutory bodies as applicable from time to time.
11. Validity of Tender shall be 120 days from the date of opening of the price Bid or revised Bid if any.
12. The management of BCCL reserves the right to reject any or all the tenders without assigning any reasons what- so- ever or to split up and distribute the work amongst the tenderers.
13. No material shall be issued by the department.
14. No Tender will be issued or submitted by postal means.
15. Issuance of Tender Documents does not mean that the party is considered qualified.
16. Conditional tender will not be accepted.
17. In case of any injury/accident it will be the responsibility of the Contractor to pay all legal dues to their workers.
