(b)Part- II i.e. price bid, containing the Tender Documents issued to the tenderers, rate will be furnished in figures and words and will be opened by the tender committee only on acceptance of the Part –I Bid.

2. The Tender paper can be had from the office of the undersigned on written request on all working day during working hours from 07.11.2011 to 09.11.2011 on payment of requisite cost as indicated above to be deposited in cash with associate finance at Sijua Area.

#### **ELIGIBILITY CRITERIA :-**

The intending tenderers must have, in the name as a prime contractor of experience having successfully completed similar works during last 7 (seven) years ending last day of month previous to the one in which applications are invited should be either of the following ;-

a) Three similar completed works each costing not less than the amount equal to 40% of the estimated cost.

Or

b) Two similar completed works each costing not less than the amount equal to 50% of the estimated value.

Or

c) One similar completed work costing not less than an amount equal to 80% of the estimated cost.

N.B."Similar completed works means, civil construction works successfully completed in underground mine."

3 The tenderers must have average annual financial turn over during last three years ending 31<sup>st</sup> March of previous financial year i.e. in 2008-09, 2009-10 & 2010-11 should be at least 30% of the estimated cost.
