1. ELIGIBILITY CRITERIA;

- (a)The intending tenderer must have in its name as a prime contractor experience of having successfully completed similar works during 7(seven)years ending last day of month previous to the one in which bid applications are invited(i.e. from 01.08.2004 to 31.07.2011) should be either of the following:

Three similar completed works each costing not less than the amount equal to 40% of the estimated cost.

OR

Two similar completed work each costing not less than amount equal to 50% of the estimated cost

OR

One similar completed work costing not less than the amount equal to 80% of the estimated cost.

N.B. Similar work means : Cleaning of ash/drain/garbage/railway track for sl.no.1, repairing work with RCC for sl.no.2,ISI mark for tarfelt work for sl.no.3,repairing of boundary wall for sl.no.4 ,pipe line work for sl.no.5 and 6 only.

- (b) Average annual financial turn over of civil work during the last 3(three) YEARS ENDING 31ST March of the previous financial year(i.e.2008-2009,2009-20010 & 2010-11) should be least 30% of the estimated cost(To be submitted T.D.S. Form-16).

The intending tenderer must submit documentary evidence in support of 1 (a) & (b) above in the form of certified copy of work order, completion certificate, payment certificate vouchers etc. indicating the period of work for which the payment has been made duly signed by him/them.

NOTE : (i) Provision under eligibility criteria 1.(a) shall also include those similar works “ while considering the value of completed works, the full value of completed works be considered whether or not the date of commencement is within the said seven years period.

(ii) As per eligibility criteria specified under Sl.No.1(a) Pre-qualification shall be done based on experience of successfully completed works and not on experience of work in progress.

1. The tender documents can be had from the office of the Area Civil Engineer, Sijua Area during the period mentioned above on deposition of requisite cost of tender paper in form of cash or Bank draft of Nationalised Bank/schedule commercial Bank approved by Reserve Bank of India in favour of Bharat Coking Coal Limited payable of Dhanbad.
2. Completed sealed tender documents (Part I & II) should be submitted at the same time .

Part-I shall consist of terms and conditions of the tender, additional terms and conditions if any, technical bid and credentials.

Envelope –III should contain part-II i.e. price bid.

9. The experience as given in the eligibility criteria should be in the name and style in which tender is filled. The experience in the name of some other firm/company will not be considered for this purpose.
10. The validity of the tender will be 120 days from the date of opening of price bid or revised price bid if any. Which ever will be later.
11. The management of BCCL reserves right to reject any or all tender or split the work among two or more tenderers without assigning any reasons whatsoever.
