- 1. Sealed Quotation should be submitted in the tender box of purchase department, Sijua Area-V or should reach by post to Area Manager (MM), Sijua Area-V, BCCL, P.O. Sijua, Dhanbad on or before 29.11.2011.
- 2. Offers to be submitted in two bids. (Techno Commercial & Price bids) in separately sealed envelopes. The Techno Commercial bid must contain the following.

## **TECHNICAL SPECIFICATION**

- a) Product DGMS approved cement capsules for roof bolting in mine size 32mmdiax400mm length perforated polytube. Cement capsules shall be standard composition and properties as per DGMS Tech. circular (approval) no.5 dated 27.12.2010
- Notarised copy of valid DGMS approval granted for manufacturing of the product test report and technical specification of product must be submitted for techno commercial bid.
- c) Confirmation that provisions of DGMS Tech. circular (approval) no.5 dated 27.12.2010 and conditions of DGMS approval fully complied by the manufacturer.
- d) For better handling 50 no. cement capsules shall be suitably packed in water proof bags. The consignment shall be suitably protected against extreme weather condition which may alter the property of the product
- e) Name of manufacturer batch no. & date of manufacturing weighment and date oexpiry must be so printed on each and every bag that they are not damaged in transit Tagging in bag is not allowed.
- f) The self life of cement capsules shall be minimum six month from the date of supply
- h) Confirmation that if at any time, product is found not meeting any of the stipulated parameters of DGMS Tech. circular(approval)no.5 dated 27.12.2011 then whole consignment shall be destroyed at user end under intimation or in presence of supplier and no claim for payment shall be accepted for the said supply.
- i) Test report as per DGMS Tech. circular (approval) no.5 dated 27.12.2010 from single test house approved by DGMS shall be submitted for Tech. commercial bid(part-1)
- j) All the above eligibility criteria must be fulfilled for qualifying in part.1
