1. The tenderers should submit their tender in two separate envelopes indicating the cover "Technical Bid" and "Commercial Bid".

ELIGIBILITY CRITERIA

2. The intending tenderer must have in its name experience of having successfully completed similar works during last 7 (seven) years ending last day of the month previous to the one in which bid applications are invited (i.e. eligibility period) should be either of the following:

*Three similar completed work each costing not less than amount equal to 40% of the estimated cost

OR

*Two similar completed work each costing not less than amount equal to 50% of the estimated cost

OR

*One similar completed work costing not less than amount equal to 80% of the estimated cost.

*Similar work means : Civil works in U/g. Mine.

4. Tenderers should also give the breakup of activities along with the time schedule for completion of the job to be completed in three months.

5. Tender documents with full details & specification can be have from the office of the undersigned from 18.07.2011 to 21.07.2011 and sealed tender will be received up to 4PM on 22.07.2011. The sealed tender of Technical bids (Part-I) will be opened on 22.07.2011 at 4.30 PM. before the tenderer or their authorized representatives. Commercial bids will be opened

only after the department is satisfied that the criteria fixed are fulfilled. NIT can be seen and down loaded from BCCL website no. <http://bccl.cmpdil.co.in>. In case of tender documents down loaded from BCCL site cost of tender paper should be deposited in form of Demand draft in favour of BCCL.

6. Authority reserves the right to reject any or all the tenders without assigning any reason whatsoever and split up the work between two or more Tenderers.

7. Earnest money in shape demand Draft in favour of BCCL, Cash Credit A/C payable at any Nationalised Bank at Dhanbad.

8. It will be obligatory for the tenderers to keep their offer open for acceptance for a period of 120 days from the date of opening of the price bit or from the date of negotiation.
