Eligibility criteria:-

- a) The intending tenderer must have in its name as a prime contractor experience of having successfully completed similar works during last 7 (seven) years ending last day of month previous to the one in which bid applications are invited (*i.e. from 01.11.2004 to 31.10.2011*) should be either of the following :-
Three similar completed works each costing not less than the amount equal to 40% of the estimated cost.
(OR)
Two similar completed works each costing not less than the amount equal to 50% of the estimated cost.
(OR)
One similar completed work costing not less than the amount equal to 80% of the estimated cost.
- b). **Similar work means:** Civil work.
- b) Average annual financial turnover of civil works during the last 3 (three) years, ending 31st March of the previous financial year (*i.e. for, 2008-09, 2009-10 & 2010-11*), should be at least 30% of the estimated cost.
