The Price Bid (Part-II) of only those Tenderers will be opened later on for whose PART-I offer/tender will be found to be Techno-commercially acceptable to Western Jharia Area, BCCL. The opening date & time of Price Bid (Part-II) will be intimated through a letter to only such bidders/Tenderers whose Part-I offer has been found acceptable.
