General Instruction for submission of discount bids:

1)The contractor is required to submit his/her discount offer in sealed cover giving reference to this notice number and date as well clearly superscribing the cover co with the name of the work.Separate cover is to be used for each work.

9) The tendered sum so corrected and altered shall be substituted for the sum

originally tendred and considered for acceptance instead of the original sum quoted by the bidder alongwith.
