In case the bidder is not a prime contractor but a sub-contractor, the bidder's experience as sub-contractor will be taken into account if:-

- The contract in support of qualification is a sub-contract in compliance with the provision of such sub-contract in the original contract awarded to prime contractor.
- b) Evidence of possessing adequate working capital (at least 20% of the Annualised value of this work) inclusive of access to lines of credit and availability of other financial resources to meet the requirement.
