ELIGIBILITY CRITERIA

2) Average Annual turnover of "W/Bridge" work during the last 3 years, ending 31st March

of the previous financial year, should be at least 30% of the estimated cost.

3) The intending Tenderer must have experience of having successfully completed similar

works during last seven years ending last day of month previous to the one in which applications are invited (i.e. eligibility period) should be either of the following:

(a) Three similar completed works each costing not less than the amount equal to 40% of the estimated cost.

b) Two similar completed works each costing not less than the amount equal to 50% of the estimated cost.

c) One similar completed work each costing not less than the amount equal to 80% of the estimated cost.

Note: a) Provision under eligibility criteria under Sl.No.2 shall also include those similar works that have been started earlier than eligibility period of tender but completed during the eligibility period as per NIT.
