 - 2)The Bidders is encouraged to visit and examine the site of works and its surroundings and obtain all information that may be necessary for submitting the bid. The costs of visiting the site shall be at the Bidders own expense and it shall be deemed that the bidder has visited the site/area.
 - 3)The bidders shall offer for the whole works as described in bill of quantity submitted by the Bidder. However, the Employer reserves the right to allot part of the work at their discretion and not claims, whatsoever, shall be entertained in this regard.
 - 4)The Bidder shall fill-in rates and prices for all items of the works describes in the Bill of Quantities. Corrections, if any, shall be made by crossing out, initiating, dating and rewriting. 5)Any Bid received by the Employer after the deadline prescribed in the discount bid notice due to any reason whatsoever will not be accepted.
 - 6)Information relating to the examination, clarification, evaluation and comparison of Bids and recommendations for the award of a contract shall not be disclosed to Bidders or any other persons not officially concerned with such process until the award to the successful Bidders has been announced.
 - 7)Any effort by a Bidder to influence the Employeer's processing of Bids of award decisions may result in the rejection of his Bid.
 - 8)Bids determined to be substantially responsive will be checked by the Employer For any arithmetical errors. Errors will be corrected by the Employer as follows:
 - a) Where there is a discrepancy between the amounts in figures and in words, the amounts in words will govern; and
 - b) where there is a discrepancy between the unit rate and the line item total resulting from multiplying the unit rate by the quantity, the unit rate as quoted will govern.
 - c) Discrepancy in totaling or carry forward in the amount quoted by the contractor shall be corrected
 - 9) The tendered sum so corrected and altered shall be substituted for the sum
